

TERMS AND CONDITIONS OF LIFESTYLES UNLIMITED MEMBERSHIP

Program Benefits:

Active Challenge members in good standing have access to the following programs and services:

All programs and services available with the Financial Freedom Program (FFP) plus the following:

- Challenge education classes including in person, on-line, live and record webinars, and live stream events.
- Single Family Mentoring in person or via telephone, skype or other similar online services and email during office hours, Monday through Friday, excluding holidays, from 10AM-4PM CST.
- Single family educational and acquisition Road Trips.

NOTE: Neither Lifestyles nor any presenter or employee has any responsibility to maintain the Challenge Program information made available to me or to supply any correction or update about such information.

Conditions of Membership:

- ***If I am engaged in the business of real estate education and/or mentoring, or plan to engage in the business of real estate education and/or mentoring in the future, which includes mentoring, coaching, broadcasting, content development, and/or under the direction of or otherwise affiliated with such individuals and/or companies I am ineligible for membership with Lifestyles.***
- I will make my own decisions and will consult with my own business advisors, attorneys and tax and accounting advisors concerning any investment or transaction in which I may decide to invest or participate.
- ***I will attend all events solely for the purposes of my own real estate education.***
- I hereby irrevocably grant to the Lifestyles Parties the right to make audio and visual recordings (still or motion) and other reproductions of (a) my name, likeness, image and/or voice, and (b) any and all activities of every kind and nature whatsoever in which I may participate at any location where Lifestyles is sponsoring or participating in any activity or is otherwise legally entitled to be present during the time I am a Lifestyles member. I acknowledge that Lifestyles Unlimited has several affiliated companies including Real Estate Brokerages and all Lifestyles Unlimited offices and events are also Lifestyles affiliated brokerage offices and events. CONDUCTING ANY PERSONAL BUSINESS IN FURTHERANCE OF MY REAL ESTATE AGENCY PROFESSION OR ANY OTHER BUSINESS IS A VIOLATION OF THIS AGREEMENT THAT WILL RESULT IN TERMINATION OF MY MEMBERSHIP, ANY LICENSE PROVIDED TO ME TO ATTEND ANY EVENT OFFERED BY OR SPONSORED BY LIFESTYLES WILL BE REVOKED AND I WILL BE CONSIDERED TO BE CRIMINALLY TRESSPASSING THEREIN, IF I CONTINUE TO ATTEND.***
- Everyone in attendance at an event has the right to learn in an environment free of unnecessary distractions and/or interruptions. If I do anything that disrupts the natural flow of the event and/or inhibits Lifestyles team members, educators and/or presenters to deliver the material or services as intended, I understand I will be asked to leave the event and my membership may be terminated.

I WILL NOT SELL, EXCHANGE, TRADE, BARTER, PROVIDE, LEND, GIVE, ADVERTISE OR OTHERWISE MAKE PUBLIC ANY LIFESTYLES' MEMBER PERSONAL INFORMATION, INCLUDING BUT NOT LIMITED TO THEIR NAME, ADDRESS, EMAIL, PHONE NUMBERS, SOCIAL MEDIA OR OTHER CONTACT INFORMATION, FINANCIAL INFORMATION, INVOLVEMENT IN ANY PARTICULAR PROJECT OR INVESTMENT OR ANY OTHER INFORMATION, TO ANY THIRD PARTY, FOR ANY PURPOSE, WHATSOEVER.***
- I will not misrepresent my relationship with Lifestyles. The Lifestyles Unlimited name, logos, terms, slogans, etc. are the property of Lifestyles and I may not use them for my own purposes including to misrepresent my relationship with Lifestyles.
- I will not engage in any direct business transaction with any Lifestyles employee, independent affiliated contractor, Vendor or other Member that violates any applicable Federal, State or local law, regulation, rule, code and/or ordinance.
- I will not misrepresent my Membership level or my authorization to participate in any Lifestyles Unlimited Membership Program, including the Challenge and Preferred Investor Group Programs, to any Lifestyles employee, independent affiliated contractor, Vendor, other Lifestyles Member, or anyone else within or outside of the Lifestyles community of real estate investors.
- ***I will contact my Customer Service Manager if, as an Challenge member, I plan to make an offer on an apartment community. I will "tag" the property and abide by the tagging rules so as not to compete with other Lifestyles members. I understand that failure to do so will result in termination of my membership.***
- I will not mistreat Lifestyles and its affiliated companies' employees, independent contractors, vendors, volunteers or members. I understand I am here to learn from them during regular business hours and I will not be disruptive, place unreasonable demands on them, request things beyond the scope of my membership, or behave in an unprofessional or abusive way. I understand that failure to maintain a reasonable, professional decorum will result in immediate termination of my membership.
